Public Comments for P.A. 096-0903: The rules to SB 226 regarding principal preparation redesign have been posted on the ISBE web site. Attached (see first attachment) is a hard copy of the rules. Please take an opportunity to respond to the rules as your voice is needed and encouraged.
