DISCUSSION: Admission Numbers were shared during the open house but were not posted. Interested parents are interested in availability. There seemed to be confusion on where the information was presented.

How much is the expansion / attrition issues going to impact Metcalf now \& in the near future?
Need to figure out space / class size \& facility availability.
New facilities campaign - ask donors / state legislation / who wants to partner with the lab schools. There were 1400 students who wanted to attend the lab schools last year - the issue isn't people don't want to attend the lab schools, it's space.

Think about numbers with additional needs.

Dr. Jones still getting questions about having Special Education student at the lab schools.
What are we doing for the current students who need additional support? Connect current students to the psychology department.

Should we be utilizing resources at ISU more? Reestablishing the partnerships with ISU.
