## About the Program

The combination principal preparation-director of special education (DOSE) master's degree is a 42 credit hour program that leads to principal endorsement and contains the requirements for DOSE coursework. Students must take and pass state licensure tests as well. The program culminates with an internship experience where students are paired with a principal/administrator with a special education background. Graduates of this program are prepared for a range of leadership positions in Illinois schools. The next cohort begins in the fall of 2024.

## Applicant Criteria

- Must be a professionally licensed teacher.
- Cumulative GPA of 3.0 in a 4.0 scale for either the last 60 hours of undergraduate course work or any previous work in a master's program
- Must have two years of full time teaching experience as an LBS1, DHH and/or LVB.

- Prospective candidates will be interviewed by representative faculty and advisory committee partners and will respond in writing to a problem scenario
