## Qualifications

The P-12 Ed.D. is designed for school leaders who have:

Demonstrated at least two years of effectiveness as a building or central office administrator/leader. Must have principal licensure.

Strong academic credentials and an interest in conducting scholarly research on a problem of practice.

## Location/Format

The P-12 Administration Ed.D. is an online program. Fall and spring courses take place in the evening in a stacked format (two courses back-to-back). Summer course work is offered in a compacted format.

## Cost

The current in-state tuition cost for a 3-credit course is approximately \$1,700. *Tuition costs may increase annually*

## Requirements

The program requires 51 hours of course work beyond a masters degree followed by 15 hours of dissertation research.

Doctoral residency requirements are fulfilled during the program.

The application requires:

1. Academic writing sample
2. Up-to-date resume
3. Answers to questions about your research interests & goals
4. Evidence of completed Principal Licensure
5. Two references

References must address these criteria:

- Leadership experiences and ability to collaborate in a team
- Strong communication and academic writing skills demonstrating analytical and critical thinking ability
- Ability to conduct academic research independently
